REGULATION NO. 44/2022
of the Rector of the Wrocław University of Economics and Business
of 16 March 2022

on the form of teaching classes

Under Article 23(2)(2) of the Law of 20 July 2018 on Higher Education and Science (Journal of Laws of 2021, item 478, as amended), in connection with the Act of 2 March 2020 on Special Solutions to Prevent, Counteract and Combat COVID-19, other Infectious Diseases and Ensuing Crisis Situations (consolidated text of Journal of Laws of 2021, item 2095, as amended), it is ordered as follows:

§ 1

1. Starting from 4 April 2022, all forms of teaching, subject to sections 2-5, at Bachelor's and Master's degree programmes, doctoral programmes, the Doctoral School, the University of the Third Age (Branches in Wrocław and Bolesławiec), the Economic Children's University and the Academy of Young Economists are conducted in a full-time form.
2. In justified cases, the Dean of the Doctoral School may give permission for lectures to be delivered remotely in the Doctoral School by lecturers not employed under a contract of employment at the Wrocław University of Economics and Business.
3. The supervisor decides on the form of the diploma seminar.
4. Throughout the summer term 2021/2022 for undergraduate and postgraduate courses (excluding EMBA) and doctoral studies, only those courses which were taught through e-learning until 10 March 2020 may be taught remotely. The instructor shall be obliged to inform, as appropriate, the relevant course manager or the relevant doctoral programme coordinator about their wish to conduct classes in this form.
5. The form of teaching on the EMBA degree programme is determined by the Director of the EMBA Programme.
6. The decision on the form of teaching activities for postgraduate extension programmes shall be made by the head of postgraduate extension programmes, informing the Head of the Centre for Continuing Education of his/her decision.

§ 2

Up to 25% of each remote course may be conducted asynchronously on the Moodle platform, while at least 75% should be conducted synchronously via the Teams module of Office 365.

§ 3

Starting from 4 April 2022 consultations as a rule take place onsite: During this period, remote consultations may only be held by instructors who conduct classes remotely according to the provisions of § 1 sections 2 and 5. Irrespective of the form of consultations, they must be conducted in line with the

principles specified in Regulation No. 22/2017 of the Rector of the Wrocław University of Economics and Business.

§ 4

Regulation No. 23/2022 Rector of the Wrocław University of Economics and Business is repealed as of 4 April 2022

§ 5

The Regulation enters into force on the day of signing and becomes effective as of 4 April 2013.
