REGULATION NO. 100/2022 of the Rector of the Wroclaw University of Economics and Business

of 12 July 2022

on determining the procedure for granting the status of an affiliate professor, affiliated researcher or affiliated lecturer at the Wroclaw University of Economics and Business

Pursuant to § 71 of the Statutes of the Wroclaw University of Economics and Business, it is ordered as follows:

§ 1

- The Rector, either on his own initiative or at the request of a faculty dean, may grant for a definite period of time, to a person who is not an employee of the University and who participates in the University in carrying out scientific research or conducting university classes, the status of an affiliate professor, affiliated researcher or affiliated lecturer at the Wroclaw University of Economics and Business.
- 2. The Rector grants the status of an affiliate professor to a person participating in the WUEB in carrying out scientific research and conducting university classes.
- 3. The Rector grants the status of an affiliated researcher to a person participating in the WUEB in carrying out scientific research.
- 4. The Rector grants the status of an affiliated lecturer to a person participating in the WUEB in conducting university classes.

§ 2

- 1. A request for granting the status of an affiliate professor, affiliated researcher or affiliated lecturer may be submitted by a faculty dean.
- 2. A request for granting the status of an affiliate professor, affiliated researcher or affiliated lecturer at the WUEB requires a positive opinion by the faculty board.
- 3. An application for granting the status of an affiliate professor, affiliated researcher, or affiliated lecturer at the WUEB shall include in particular:



- 1) information on the candidate:
 - a) first name and surname,
 - b) scientific or professional qualifications,
 - c) achievements, scientific, didactic or professional output,
 - d) information on the current place or places of work,
- 2) determining the scope of work in which the candidate will participate in scientific research, conducting university classes or other forms of activity, in particular providing consultation to employees, students, or doctoral students.

§ 3

- 1. The status of an affiliate professor, affiliated researcher, or affiliated lecturer at the WUEB entitles in particular to:
- 1) conducting scientific research or university classes at the WUEB;
- 2) participating in the programmes, projects, or undertakings carried out by the WUEB.
- 2. The detailed rules for using the rights referred to in section 1 shall be determined by the Rector when examining the application.

§ 4

- 1. The Rector, either on his own initiative, or at the request of a faculty dean, or at the request of an affiliate professor, affiliated researcher or affiliated lecturer, may change the period for which the status referred to in § 1(1) has been granted. The request referred to in the first sentence shall not require a re-examination of the faculty board.
- 2. In justified circumstances, in particular, in the case of using the rights in a way that is non-compliant with the decision of the Rector by an affiliate professor, affiliated researcher, or affiliated lecturer, the Rector on his own initiative or at the request of the faculty dean may withdraw the granted status.
- 3. A person who has lost the status of an affiliate professor, affiliated researcher, or affiliated lecturer in the circumstances referred to in section 2 shall not be granted the status again.

§ 5

1. An affiliate professor shall use the status name after the surname: 'profesor afiliowany UEW', and in English WUEB Affiliate Professor.



- 2. An affiliated researcher shall use the status name after the surname: 'badacz afiliowany UEW', and in English WUEB Affiliated Researcher
- 3. An affiliated lecturer shall use the status name after the surname: 'wykładowca afiliowany UEW', and in English WUEB Affiliated Lecturer.

§ 6

The administrative support for collecting and circulating documentation shall be carried out by the competent office of the department.

§ 7

The Regulation becomes effective on the day of its signing.
