## **REGULATION NO. 10/2022**

## of the Rector of Wroclaw University of Economics and Business

of 25 January 2022

# on the implementation of teaching activities and winter examination session of the academic year 2021/2022 at the Wroclaw University of Economics and Business

Pursuant to Article 23 (2) (2) of the Act of 20 July 2018. – Law on Higher Education and Science (consolidated text Dz. U. – Journal of Laws of 2021, item 478, as amended) in conjunction with the Act of 2 March 2020 on Special Solutions related to the Prevention, Counteraction and Combating of COVID-19, other Infectious Diseases and Ensuing Crisis Situations (consolidated text Dz. U. – Journal of Laws of 2020, item 1842, as amended), it is ordered as follows:

### § 1

- 1. Until the end of the winter semester, that is until 03.02.2022, all teaching activities at the Wroclaw University of Economics and Business at the first-cycle studies, second-cycle studies, and the doctoral programme and doctoral school shall be conducted in a remote form.
- 2. Up to 25% of each course may be conducted asynchronously on the Moodle platform, while at least 75% should be conducted synchronously via the Teams module of Office 365.
- 3. All final assessment attempts, including those taken at resit dates, shall be conducted in a remote form until 28.02.2022.
- 4. The examinations in the examination session both at an early exam date, first-attempt date, second-attempt date (and the "last-chance" examinations conducted before an examination board), at the first-cycle studies, second-cycle studies, the doctoral programme and Doctoral School in the period of 26.01.-28.02.2022 shall be conducted in a remote form.
- 5. In order to conduct examinations at a first-attempt date, second-attempt date in the period earlier than that provided in the calendar of academic years, the consent of the students shall be required.
- 6. Viva voce examinations shall be conducted in a remote form until 01.04.2022.
- 7. The decision on the form of teaching activities and form of examinations for the Executive Master of Business Administration (EMBA) degree programme shall be made by the Head of the EMBA programme.
- 8. The decision on the form of teaching activities and the form of examinations for postgraduate extension programmes shall be made by the Head of postgraduate extension programmes, informing the Head of the Centre for Continuing Education of his/her decision.
- 9. The Rector's relevant Plenipotentiaries shall make decisions on the form of teaching activities at the University of the Third Age Wrocław and Bolesławiec Branches.
- 10. Consultations until 28.02.2022 shall be held in a remote form in accordance with the principles set out in the Regulation No. 22/2017 of the Rector of Wroclaw University of Economics and Business.



§ 2

As of 25.01.2022, the following shall be repealed:

- Regulation No. 3/2022 of the Rector of the Wroclaw University of Economics and Business of 04.01.2022 on the implementation of teaching activities at the Wroclaw University of Economics and Business.
- 2. Circular Letter no. 1 of the Rector of the Wroclaw University of Economics and Business of 13 January 2022 on the form of conducting *viva voce* examinations, final assessment attempts and exams taken at early exam date in the winter semester of the academic year 2021/2022
