

# R-B-SOP.021.1.3.2022 **REGULATION NO. 3/2022** of the Rector of the Wroclaw University of Economics and Business of 04 January 2022

### on conducting teaching activities at the Wroclaw University of Economics and Business

Pursuant to Article 23(2) item 2 of the Act of 20 July 2018 – Law on Higher Education and Science (i.e. Journal of Laws of 2021, item 478, as amended) in connection with the Act of 2 March 2020 on special solutions related to preventing, counteracting and combating COVID-19, other infectious diseases and emergencies caused by them (i.e. Journal of Laws of 2020, item 1842, as amended), it is hereby ordered as follows:

#### **§ 1**

- 1. From 8 January 2022 until the end of the winter semester, i.e. until 3 February 2022, at the Wroclaw University of Economics and Business, all courses on first and second-cycle studies as well as on doctoral studies and in the Doctoral School shall be conducted in a remote form.
- The exams in the examination session at both the first and second sitting (as well as the exams conducted before an examination board) on first and second-cycle studies as well as on doctoral studies and in the Doctoral School shall be conducted in a stationary form on the premises of the University.
- 3. The decision on the form of conducting classes within the time limit referred to in section 1 and on the form of conducting exams at the Executive Master of Business Administration Program (EMBA) shall be made by the Director of the EMBA Program.
- 4. The decision on the form of conducting classes within the time limit referred to in section 1, at the Children's University of Economics, the Young Economist Academy and the Third Age University (applies also to the branch in Bolesławiec) shall be made by the relevant Representative of the Rector.
- 5. The decision on the form of conducting classes within the time limit referred to in section 1 and on the form of conducting examinations on post-graduate studies shall be made by the director of post-graduate studies, informing the Director of the Life Long Learning Center about the decision.
- 6. Defence of theses carried out within the time limit referred to in section 1 shall be carried out in a remote form.
- 7. Consultations within the time limit referred to in section 1 shall be held in a remote form in accordance with the rules specified in Regulation No. 22/2017 of the Rector of the Wroclaw University of Economics and Business.
- 8. Up to 25% of classes from each subject conducted in a remote form are allowed to take place asynchronously using the Moodle Platform, while at least 75% should take place synchronously using the Teams module of the Office 365 package.



## § 2

As of 8 January 2022, the following Regulations of the Rector of the Wroclaw University of Economics and Business are hereby repealed:

- 1. Regulation No. 103/2021 of 31 August 2021 on the form of teaching in the winter semester of the academic year 2020/2022.
- 2. Regulation No. 121/2021 of 28 September 2021 on introducing a remote form of conducting lectures on full-time and part-time first and second-cycle studies in the winter semester of the 2021/2022 academic year.
- 3. Regulation No. 184/2021 of 22 December 2021 on conducting teaching activities at the Wroclaw University of Economics and Business.

#### § 3

This Regulation becomes effective as of its signing date.
