REGULATION NO. 8/2021

of the Rector of the Wroclaw University of Economics and Business

of 25 January 2021

on the conduct of classes in the summer semester of the academic year 2020/2021


Pursuant to Article 76a(2) of the Law on Higher Education and Science (J. of Laws of 2020, item 85, as amended) and in connection with the Act of 2 March 2020 on Special Solutions Related to Preventing, Counteracting and Combating COVID-19, Other Infectious Diseases and the Resulting Crisis Situations (J. of Laws of 2020, item 374, as amended), I hereby order as follows:

§ 1

- Classes in the summer semester of the academic year 2020/2021 as part of the 1st and 2nd cycle programs, subject section 3, doctoral programs, and the Doctoral School classes will be held remotely.
- Physical education classes as part of the intramural 1st cycle programs will be held remotely. They will be theoretical in nature, with an academic teacher recommending exercises to be done by students on their own.
- Classes as part of the Executive Master of Business Administration (EMBA) program will be held remotely. In exceptional cases, upon a reasoned written request of the EMBA Program Director, the Vice-Rector for Student Affairs and Education may agree to some of the above-mentioned classes being held in an intramural arrangement.
- Classes conducted as part of postgraduate programs and training programs will be held remotely. In exceptional cases, upon a reasoned written request of a competent manager of a postgraduate program or a competent leading trainer responsible for a training program, the Vice-Rector for Student Affairs and Education may agree to some of the above-mentioned classes being held in an intramural arrangement.
- Classes at the University of the Third Age in Wroclaw and at the Branch in Boleslawiec are suspended until further notice.
- 6. Classes at the Children's Economic University and the Academy of Young Economists may only be conducted remotely.
- 7. Tests should be conducted remotely.
- The procedure for conducting the summer examination session of the academic year 2020/2021 will be 8. determined by a separate Regulation of the Rector during the summer semester.
- 9. Internships of students of 1^{st} cycle programs will take place in the manner specified by relevant employers.
- 10. Consultations will be held remotely, on dates and at times specified in Regulation No. 22/2017 of the Rector of the Wroclaw University of Economics and Business.
- 11. Seminar students of Management and Production Engineering are allowed to conduct research necessary to prepare their engineer's or master's theses at the premises of the University, provided that they comply with the applicable sanitary safety requirements and University recommendations, including an obligation to wear mouth and nose covering, disinfect hands, and maintain social distance.
