**Metody dydaktyczne:**

Workshops with great participation of students. Working in groups on a given topic; debates and simulation of EU law adoption, negotiations in the Council of the European Union and negotiations of regional authority with European Commission; student's presentations.

**Cele przedmiotu:**

The aim of the course is to acquaint student with history, basic rules, principles and policies of the European Union. Student should be able after this course to answer the questions: what is European Union? How and why it was created? What stages of the European integration process can we distinguish? What is the responsibility of each EU main institution? And the last, most general question: how does it work?
