

ACCA TRAINING DAY AT THE UNIVERSITY OF ECONOMICS IN WROCŁAW

Objectives

- ▶ To familiarise participants with professional learning requirements.
- To enable participants to compare professional qualifications like ACCA to other (academic) qualifications.
- To provide some knowledge and understanding of a few important concepts and techniques used in day to day decision making.
- ► To familiarise participants with sample ACCA questions to get the feeling of both the level of difficulty and types of questions asked.
- ➤ To help participants understand the importance of exam technique and proper time management.
- ► To contrast participants' present knowledge and experience with the level required for a successful candidate.

Who for

This training session would be most suitable for ambitious students of any faculty who are eager to progress in their business careers and are investigating professional qualifications to boost their skills in the future.

Methodology

The course will consist of two parts:

<u>Part 1</u> - will focus on the presentation of the ACCA qualification ranked by many as the number one accounting qualification in the world. As an introduction, we will discuss the role of professional qualifications in career development.

<u>Part 2</u> - this part will concentrate on two cases representing **real ACCA type questions**. This section not only concentrates on the merits of both cases but also **includes exam hints**, marking schemes, and **time management techniques**.

Case study 1

Financial reporting: scenario based on a mixture of ACCA F3 and F7 papers covering the following areas:

- financial statements presentation: the key components and what they are telling to the reader
- step by step guidance on particular assets and liabilities valuation
- the usefulness of historic information included in the financial statements
- professional judgment: how to apply this nice concept in practice
- creative accounting examples and ways to track them down
- who is the king: profit or cash?

Case study 2

Project appraisal: scenario based on the ACCA F9 paper covering the following areas:

- capital budgeting and investment appraisal techniques
- identification and calculation of the relevant cash flows for investment projects
- incremental cash flows
- discount rate: factors to be taken into account
- cost of equity, cost of debt and weighted average cost of capital
