## **REGULATION NO. 66/2020** of the Rector of the Wroclaw University of Economics and Business of 13 May 2020

### on the implementation of the diploma admission process at the Wroclaw University of Economics and Business

Under Article 76(1) to (2) of the Law of 20 July 2018 on Higher Education and Science (Journal of Laws of 2018, item 1668, as amended) and § 10(1) point 11 of the Statute of the Wroclaw University of Economics and Business (Resolution of the Senate no. R.0000.60.2019 of June 10, 2019) and the Rules and Regulations for Studies at the Wroclaw University of Economics and Business (adopted by the Resolution of the Senate no. R.0000.51.2019 of 25 April 2019), I hereby order as follows:

#### **§**1

The principles of the implementation of the process of diploma admission performed at the Wroclaw University of Economics and Business are hereby established by determining:

- 1. Bachelor's thesis standards for theses prepared at the Wroclaw University of Economics and Business *Annex no. 1,*
- 2. Engineering thesis standards for theses prepared at the Wroclaw University of Economics and Business *Annex no. 2*,
- 3. Master's thesis standards for theses prepared at the Wroclaw University of Economics and Business *Annex no. 3,*
- 4. Exemplary formulation of a thesis Annex no. 4,
- 5. Rules for classification of diploma theses performed by students of the Wroclaw University of Economics and Business *Annex no. 5*,
- 6. Rules for conducing diploma examinations at the Wroclaw University of Economics and Business as of 2020/2021 *Annex no. 6*,
- 7. Rules for verification of diploma theses with the use of the JSA report Annex no. 7,
- 8. Composition of Thesis Verification Committees for particular programs of study Annex no. 8.

#### § 2

Pursuant to § 131 of the Statute of the Wroclaw University of Economics and Business, for diploma theses submitted by 30 September 2020, the *Diploma theses standards* in force at particular departments of the Wroclaw University of Economics and Business shall be applied before the change in the organizational structure, except as provided in the Communication of the Dean for Student Affairs/Deed of the Branch on the submission of diploma theses for the academic year of 2019/2020.


The following shall be repealed:

#### **§** 4

The regulation shall enter into force on the date signed and shall apply to:

- 1. Annexes 1 to 4 to diploma theses prepared as of the academic year of 2020/2021, subject to § 2 of this regulation.
- 2. Annexes 5 and 7 and 8 to diploma thesis submitted as of June 1, 2020.
- 3. Annex 6 as of November 1, 2020.
